Environmental Review: Exempt pursuant to Sections 15320 and 15061 (b)(3) of the State CEQA Guidelines

Staff provided detailed information on the staff report during the meeting. The public hearing opened at 2:08 pm. A chief expressed enthusiasm for continuing ongoing work with the Monte Rio Fire Department administratively. A commissioner asked for clarification about the staffing at the Monte Rio main station, specifically regarding the presence of a 3-person paid staff, which was confirmed, along with the involvement of volunteers. Another commissioner raised concerns about the reliability of revenue, and the chief explained that there is a funding agreement with the county, adjusted annually by 4.2%, though the application used an estimated 2.4% for projections. The president of the Monte Rio Board described the consolidation with Gold Ridge as a bittersweet moment for the over 100-year-old department. The Sonoma County Fire Chief Association also expressed full support for the proposal. The public hearing closed at 2:15 pm, and a commissioner expressed satisfaction with the continued support for volunteers during these reorganizations.

4.2 Gold Ridge Fire Protection District Reorganization No. 2025-02 (City of Sebastopol Fire Department)

Environmental Review: Exempt pursuant to Sections 15320 and 15061 (b)(3) of the State CEQA Guidelines

The public hearing opened at 2:24 pm, where a representative expressed excitement about a potential annexation, noting the long-standing discussions and challenges in running a combination fire department with both paid employees and volunteers. The importance of volunteer participation in critical situations was highlighted. A Sebastopol council member mentioned that there are currently 30 active volunteers at Sebastopol Fire, which contributed to the decision to choose Gold Ridge FPD. The Sebastopol firehouse has been transferred to Gold Ridge for improvements. The public hearing closed at 2:29 pm, and a commissioner expressed appreciation for Gold Ridge's efforts in building on these districts.

 - 6.1 Executive Officer's Report:

Update regarding status of the California Association of Local Agency Commissions Kern has not been within CALAFCO for several years and Orange, San Diego, Riverside and Los Angeles are all pulling from CALAFCO with interest in returning under the right circumstances.

6.2 Legislative Affairs:

Proposal from the Community Water Center and Leadership Counsel for Justice and Accountability on legislation to expand the ability of LAFCOs to initiate reorganizations, to amplify the role of Municipal Service Reviews in communicating community needs, and to

expand the definition of special districts for LAFCO purposes to include mutual water companies.

There are over 50 mutual water companies within Sonoma County, some of which lack the funding to provide necessary services that LAFCO (Local Agency Formation Commission) might offer. Commissioner Holmer emphasized that most water companies are regulated and must meet state water requirements, especially rural ones, and added another layer of regulation may not solve the financial issues these companies face. Commissioner Hemmendinger asked if the companies involved had received input, and the Executive Officer confirmed they had, mentioning Riverside's strong interest. Commissioner Lowe expressed the need for some form of government guidance to help the public understand the issue, keeping an open mind on the topic.

This prohibition begins on the date you begin to actively support or oppose an application before LAFCO and continues until three months after a final decision is rendered by LAFCO. If you or your agent has made a contribution of \$250 or more to any Commissioner or Alternate Commissioner during the 12 months preceding the decision, that Commissioner or Alternate Commissioner must disqualify himself or herself from the decision in the proceeding. However, disqualification is not required if the Commissioner or Alternate Commissioner returns that campaign contribution within 30 days of learning both about the contribution and the fact that you are a participant in the proceedings. Pursuant to Government Code Sections 56700.1 and 81000 et seq., any person or combination of persons who directly or indirectly contributes \$1,000 or more or expends \$1,000 or more in support of or in opposition to a change of organization or reorganization that will be or has been submitted to the Sonoma Local Agency Formation Commission must comply, to the same extent as provided for local initiative measures, with reporting and disclosure requirements of the California Political Reform Act of 1974.
